Application Requirements

COMMUNITY PRESENTER YOUTHENGER MINTPROGRAM

PRIOR TO PREPARING THE FOLLOWING LIST OF DOCUMENTS THAT ARE PART OF YOUR APPLICATION BE SURE TO READ THE FULL GUIDELINES DOCUMENT.

Applicants must provide a signed, completed Application Form and all requested information.

All applications must be post-marked by the deadline (May 10, 2017) and include the following:

A written statement of no more than three pages, font size 11 or larger on single-sided white paper without staples. This is the most important part of your application. See the Guidelines for how the applications are assessed before writing your written statement.
A detailed project budget showing all revenues and expenses associated with the project
A list of the organization's current board of directors.
A list of administrative and artistic/curatorial staff or significant contractors, giving name and title or responsibility (indicate if permanent/seasonal and full-time/part-time).
Biographies of lead participating artists (max. 250 words). Please do not submit CVs.
Letters from any partnering organizations, if applicable, confirming the nature of their participation.
One copy of the organization's most recent Financial Statements (see guidelines).
One copy of a publication or brochure created by your organization or other documentation showing the current or last year's presentation series/season.

If you are planning to apply for funding in the next round of grants from the BC Arts Council-delivered Youth Engagement Program, consider carefully, as you can not receive funding from both programs. If you are successful with our application, you will not be eligible to apply to their program. Call us with any questions before

starting your application.

The application should be printed on standard letter-sized white paper and submitted unbound and without staples. NOTE—NEW: IF YOU ARE ABLE TO SCAN ALL PAGES INCLUDING THE SIGNED COVER PAGE, YOU CAN SUBMIT AS A PDF (not JPEGs or other formats) VIA EMAIL INSTEAD OF MAILING.

Select support material will be circulated to the jury only at the time of the adjudication meeting (Support material will not be returned).
